Rule M2 (b) - Replacement Certificates

The person seeking the Replacement Certificate must apply to RAS Head Office for their Replacement Certificate and have received that certificate before taking the animal to the measuring stand for ongoing measures. **Any Replacement Certificate issued direct from a measuring stand will be invalid.** Cost for a Replacement Certificate may be reduced at the discretion of the RAS Head Office.
