### RULE: ER8.k) Lease / Partnership

- i. Where the possession of a horse/pony, but not the ownership is transferred to another person. Only leases/partnerships registered with the RAS are recognised or, in the case of breed classes, leases/partnerships are registered with the affiliated Breed Society and copied to the RAS.
- ii. For any horse/pony that is not under the control of the owner, and where there is no formal registered lease/partnership lodged with the RAS, any issues arising in relation to that horse/pony becomes the responsibility of the competitor/exhibitor, handler, driver, or person resident of New Zealand or otherwise, in charge of the horse/pony that is exhibited at the Show/Event.

**THE ORIGINAL CERTIFICATE MUST BE POSTED WITH THE REGISTRATION FORM OR THE LEASE/PARTNERSHIP CANNOT BE PROCESSED. RAS WILL TAKE NO RESPONSIBILITY FOR CERTIFICATES LOST IN THE MAIL SO PLEASE USE THE TRACKED NZ POST SYSTEM. IF NO EXTRA PAYMENT SUPPLIED, RAS HEAD OFFICE WILL RETURN VIA NORMAL MAIL AT OWNER'S RISK. PLEASE ENSURE YOU TAKE A COPY OF THE CERTIFICATE FOR YOUR RECORDS.**
