

EQUESTRIAN ACCUMULATOR TRIAL 2019-2020

10 show associations within the Mid-Northern District (Waikato-Bay of Plenty) worked together to develop and deliver an equestrian accumulator competition whereby riders and their horses were able to compete across a number of shows and amass points as they go. The rider and their mount were registered for the duration of the program but could have as many registrations as desired.

North Island Premier Showing Champs hosted the first round of the Equestrian Accumulator on 18th October and last Saturday, Morrinsville A&P Society hosted the 10th and final round in conjunction with their annual show.

Participating shows contributed funds as a contribution to prize money and costs, with local identities, businesses, and organisations offering up good levels of sponsorship as well. It is these contributions that have allowed the organisers to provide a wide variety of prizes. The winner receives \$1500.00, second receives \$700.00, and third prize is \$400.00. All placings also receive a range of product prizes.
